Background of MACP:

- 1. The Government of Maharashtra through government of India has applied for a loan from the international Development Association for implementation of Maharashtra Agricultural Competitiveness Project (MACP)
- 2. The Project Development objective of the MACP is to increase the productivity, profitability and market access of the farming community in Maharashtra. This would be achieved by providing farmers with technical knowledge, market intelligence and market networks to support diversification and intensification of agriculture production aimed at responding to market demand. Farmers will also be assisted in establishing farmer organization, developing alternative market channels outside of the regulated markets. The project has three components viz.
- i) Intensification and diversification of market led production,
- ii) Improving Farmers access to markets by Promoting alternative Markets and Modernizing existing APMC and
- iii) Project Coordination and Management.
- 3. Intensification and diversification of market led production, by providing market led agriculture technology transfer to improve productivity and quality production and market information and marketing intelligence, agribusiness opportunities through Agri Business Promotion Facility (ABPF) and livestock improvement through livestock support services.
- 4. Improving Farmer access to markets by promoting alternative markets and modernizing existing APMCs, by promoting alternative marketing systems involving farmers in the producer groups & their associations, developing Farmers Common Service Centers (FCSC), introducing E-marketing platform with the help of commodity exchanges by producing Warehouse Receipt financing to overcome price risk and to provide moderate improvement in Rural Hats. Besides modernization of selected APMCs and livestock markets has also been undertaken to develop minimum required facilities, so that small ruminant & livestock owned farmers get better price to their animals.
- 5. Project management would help to ensure effective project management at the State and district levels, and support in formation and logistics, communication, project related consultancies, monitoring and evaluation, environment & social management ensuring involvement of women, tribal's, SC/ST & other backward communities.
- 6. The project intends to put in place a process that would empower farmers to be able to respond positively to the accelerating change in the Agriculture marketing by creating enabling condition and support for production systems diversification, increased farm productivity improved product quality and realization of value addition opportunities. In this context, knowledge and technology will play an important role. The component A of the project therefore, supports ATMA model of extension to reach its full potential by shifting the focus of extension from production to include marketing extension, provision of both short term market

- information and long term market intelligence coupled with greater use of information technology for information dissemination.
- 7. The project intends to set up new models in small ruminant in selected districts of the state through developing goat as high value enterprise through goat demonstrations and organizing SR farmers in groups & federating them in an associations, with an objective to motivate farmers to take up goat rearing activities as a major source of annual income and also spread local Osmanabadi breed which is reared both for meat & milk purpose in the state.
- 8. The project also intends to undertake the assignment in in-house mode involving district level authorities namely District Deputy Commission- AHD and Project Director- ATMA of respective districts. The block level Livestock Development Officers & village level Livestock Supervisors working under both the offices will assist Livestock Extension Workers appointed on contractual basis for successful completion & sustainability of the initiative. The district level authorities will coordinate with state level PIU-AHD in overall implementation of the assignment and provide local handhold, monitor, supervise and assist in process oriented & time bound assignment.

Objectives & Scope of the Assignment:

- The main objectives of the in-house initiative of goat as high value enterprise demonstrations in Satara districts are given below:
- To develop and establish750 viable goat as high value enterprise demonstrations in each district and provide necessary technical knowhow to improve productivity of small ruminants and also provide market led extension services to demo farmers.
- To undertake process oriented approach and undertake step by step activities to achieve the targets of the assignment in stipulated period of 12 months.
- The scope of the assignment includes but not limited to mobilization of SR farmers through awareness campaign, identification of SR farmers, establishing 750 demo units in each district & their capacity, organize market linkages of demo units & provide necessary support for their building sustainability.

Need for Livestock Extension Experts (LEE):

In project structure of MACP as like other project implementation units of Agriculture & Agri Marketing, the contractual staff at distirct level is not appointed under project implementation unit- AHD. So, the component activities undertaken are not monitored & supervised effectively. In the absence of independent SP, the contractual staff to be appointed under this assignment will be responsible for overall implementation of the assignment.

The AHD district level, block & village level offices are over burdened with heir routine departmental activities, so they are not able to look after this assignment on regular basis, so there is an utmost need to appoint Livestock Extension Experts. However, the AHD officers & staff will provide necessary technical knowhow, guide contractual staff on technical aspect, conduct technical training programs and other technical activities such as vaccination, buck selection, animal health camps etc. Totally 4 Livestock Extension Experts will be appointed under the assignment.

The initiative involves various processes and approaches, so the qualified & experienced staff in mobilization, hand holding of such units & market linkages is necessary. These staff will work in close coordination with local AHD staff and also coordinate with district level

authorities (DDC & ATMA) & PIU-AHD. Besides regular review of the work at DDC the Nodal Officer-PIU-AHD will also organize progress review at state level before review committee.

Qualification and experience for Livestock Extension Experts as District organizer:

Qualification and Experience for the Extension Experts:-

- 1. For this position preference shall be given to the candidate with Veterinary Post Graduate (MVSc) however if not available the Veterinary Graduate (BVSc &AH) will be preferred.
- 2. Should have 02 to 03 years extension work experience in goats & livestock.
- 3. Should be willing to work in rural area and willing for extensive travel in targeted area of the district and outside based on the requirement. Should own motor cycle and willing to travel extensively to reach SR demo farmers & for other associated work.
- 4. Candidate having experience in reputed NGOs in related field will be preferred.
- 5. Candidate should have knowledge of Marathi and prepared reports and documents related to field level activities.
- 6. Candidate should work on computer and able to prepare reports and documents in Marathi and English.
- 7. Candidate should be willing to stay in the operation area of the assignment and should own Two Wheeler.

Deliverables for Livestock Extension Expert:

The Livestock Extension Expert will perform the following tasks:-

- 1. The Livestock Extension Expert will have overall responsibility of implementation of various activities, programs and setting up of goat demos in target area of respective district.
- 2. Develop and maintain proper & regular coordination with line departments' offices at district level such as DDC, ATMA office etc. and work under their guidance & consultation for timely & successful completion of the assignment.
- 3. Will have regular communication & contacts with the field staff & block level officers of AHD & Agriculture department and ensure their involvement in various activities in targeted field area.
- 4. Will directly work under the guidance & report to the DDC Satara district and ACAH of TMVP and LDO extension of the respective block.
- 5. Ensure timely & effective compliance of activities & task assigned for the target area of the district.
- 6. Will be responsible for all field level activities to be undertaken under the assignment such as mobilization of goat farmers, organizing goat demos, and all concerned activities assigned.
- 7. Ensure that physical & financial reporting on all activities under the assignment is done to
 - DDC & Program Coordinator regularly on monthly basis. Will also made available all necessary information, reports as and when required by the DDC and PIU-AHD.
- 8. Ensure that minimum required parameters for goat demos are complied and develop minimum of 188 model demos in target area.
- 9. Ensure that all activities planned for the target area are completed in time including distribution of various inputs, training & capacity building of demo farmers, distribution of equipment's, breeding bucks, fodder crops, organizing buck melas, monitoring of
